Deputy EMA Director Munshower provided update on the LEPC exercise. Cenovus will hosted, players included Shawnee FD, Allen County Hazmat, and Cenovus. All objectives passed evaluation with notable takeaways on exercising communications further and updating Hazmat plan for responder operations.

- Shelly Gearing provided a public health update. With the excessive heat there have been many Ozone Action days, Shelly proposed sharing these notices with the LEPC. H5N1 bird flu is spreading in local populations of cattle with cases in Wood County Ohio. Three people have been found to be infected with H5N1 but none are in Ohio.
